



**Admission fee - 30,000 AMD**

**Annual fee:**

**Individual - Full: 100,000 AMD from 2027**

**- Affiliate: 50,000 AMD from 2027**

**50% discount for 2026**

**Corporate - 400,000 AMD incl. 5 individual member-representatives**



**CORPORATE**

**FULL** - at least 10 years of experience as director

According to companies' eligibility criteria

**AFFILIATE** - at least 3 years of experience as director

## ELIGIBILITY

- Companies listed on the Armenia Stock Exchange, including their c-level executives, board members and major shareholders,
- Large and medium-sized enterprises (with an annual turnover of at least 2 (two) billion AMD), including their c-level executives, board members and shareholders approved by the AIoD Board,
- All other cases shall be considered as exceptions, subject to approval by the AIoD Board.
- "Directors" are c-level executives, board members and shareholders who are:
  - more than 24 years old,
  - serve as director at least 10 years
  - serve as director at least 7 years and 3 years had been an Affiliate member of AIoD
